

Annual Seminar Survey Results

Annual Seminar Committee Chair

For the second time in the past year, the CSMFO Board of Directors conducted a member survey regarding which days of the week the Annual Seminar should be held on. The survey results did not indicate any material responses which differed from the prior survey. There were 108 responses with 42 members favoring a Wednesday through Friday format and 39 preferring the present Sunday through Tuesday format. The other 27 respondents were varied among other preferences. The Board decided to maintain the present Sunday through Tuesday timeframe. The 42 respondents favoring Wednesday through Friday only represent 5% of the membership and there was not a compelling difference (42 to 39) versus those preferring the present format. Most importantly, the board does not want to risk the positive trend in increased seminar attendance since the Sunday-Tuesday sessions
