## **Chapter Corner: Imperial County Chapter**

From time to time I receive inquiries from other cities about the CAL-Card Program. El Centro has been participating in the program for approximately 2 ½ years and I highly recommend it.

The CAL-Card Program is a program administered by the State of California, Department of General Services, Procurement Division under a Master Service Agreement (MSA) with Rocky Mountain BankCard System (RMBCS). The program enables public agencies to streamline the traditional paper and labor intensive procurement process for small dollar purchases through the use of purchasing cards.

With the ease of a widely accepted VISA card issued by RMBCS employees may make walk-in purchases or place telephone orders for goods and services up to their authorized single purchase and 30 day limits.

Under the program, the person designated by the City for program and

accounting office functions (Agency Program Coordinator or APC) determines which employees receive cards, establishes limits, and develops procedures including purchase restrictions. RMBCS maintains a master file for the City, an account for each cardholder, and sends monthly statements to each cardholder, the APC, and the City's accounting department.

We currently have 15 cardholders and over the past 2 ½ years there have been virtually no problems with the program. So if you are tired of fooling with small dollar purchases, call the CAL-Card Team at (916) 324-1333 and get the ball rolling.

## Intergovernmental Relations Committee Report

I am pleased to inform you that, after several very hectic months that included hiring a new City Treasurer, Budget Director and Administrative Services Manager, and coordinating implementation of a new computerized financial system in Long Beach, my attention is now very much focused on CSMFO Intergovernmental Relation Committee matters.

I'm back and eager to work with you as we struggle to keep our local governments fiscally sound. I'd like to highlight for you below what I believe are some of the most critical issues now before the State legislature that could have devastating effects upon local government. I believe that these are among the most important issues we'll face in the coming months:

#### 1) Vehicle License Fee (VLF)

As you are aware, there are currently several efforts underway in the State legislature to phase out or eliminate the State's Vehicle License Fee (VLF). These efforts pose the greatest threat to local government revenue sources since the State's ERAF grab. If these attempts prove successful, local governments throughout California could suffer devastating revenue losses and could be forced to make draconian cuts in local services including public safety, public works, parks and recreation, and libraries.

Although local governments are vigorously opposing VLF elimination, the popularity of this issue with voters and its political appeal could bring about its passage. We must be proactive to ensure that local governments are protected now, and over the long term, from the loss of this critical revenue stream. I encourage you to let your voice be heard

in Sacramento and to target your lobbying efforts to protect local government. Also, the League's Constitutional Amendment (ACA 42) merits your attention and support to provide Constitutional assurances that local government revenues are protected. Finally, take time to read, understand, and fully comprehend AB 1776 and ACA 45, the McClintock proposals to phase out the VLF. I urge your continued focus on this vital issue to ensure that the interests of local governments are protected during the current legislative session.

#### 2) Property Tax Revenue Shifts

One of the most alarming, and potentially divisive, approaches to the allocation of property tax to surface in a long time is Assembly Bill 2471 (Brewer). This bill would use a statewide average for property taxes labeling jurisdictions above and below the average as "overequity" and "underequity." Overequity jurisdictions would have their current property tax allocations frozen, and their property tax growth would be reallocated to the underequity jurisdictions until statewide parity is achieved. This "Robin Hood" approach is perhaps the most arbitrary and irrational methodology we've seen in a long time.

If this bill were to pass, cities attempting to grow their property tax base through improvements to their commercial developments, redevelopment activities, and maintenance of housing stock would not receive the benefits of their hard work. And, if larger cities that serve as regional economic centers are negatively affected, the bill's impact is likely to resonate beyond their borders.

Some jurisdictions may feel they stand to gain benefits because this bill would create winners and losers. However, we

must keep in mind that we all stand to lose under this irrational and divisive effort to redistribute property taxes.

Today, we have been notified that the author of AB 2471 intends to pull this bill. Nevertheless, I encourage you to examine this legislation closely and oppose it, if it is not pulled or returns to the floor.

#### 3) Home based Businesses

AB 2065 (Cardenas) would grant exemptions to many home based businesses from local business license fees and taxes. The League opposes this bill because it impacts local revenues, neighborhood quality of life and land use control. You may want to pay particular attention to AB 2065 because, if your city is like many others, your home based businesses have recently been growing at an astounding rate. The revenue losses you could incur if this bill passes could be much higher than in previous years. You may be surprised at how much you stand to lose if this effort succeeds.

## 4) Educational Revenue Augmentation Fund (ERAF)

As we mentioned above, the threat to the VLF will command our attention throughout the summer. In fact, some observers have characterized the elimination of VLF as adding insult to injury, with the injury being the State's infamous ERAF grab. Let us not be so distracted by this latest insult as to forget the grievous injury the state inflicted on local governments by the original ERAF grab. The return of local revenues taken away by ERAF should be an area of unwavering attention and continued vigilance.

Your input and suggestions on these and other legislative issues affecting cities are welcome.

### **GFOA Recommended Practices**

Recommended Budget Practices of the National Advisory Council on State and Local Budgeting (NACSLB) (1998)

Recently, GFOA published a set of recommended practices. Here is a portion of that publication.

#### Background.

Governments make program and services decisions and allocate scare resources to programs and services through the budget process. As a result, the budget process is one of the most important activities undertaken by governments. The quality of decisions resulting from the budget process and the level of their acceptance depends on the budget process that is used.

Finding that too little information about effective budgeting practices existed and that an effort to identify and share recommended practices in budgeting was needed, GFOA and seven other state and local government associations created the National Advisory Council on State and Local Budgeting (NACSLB) in 1995 and charged it with developing a set of recommended practices in the area of state and local budgeting. In December 1997, the Council concluded its work by adopting a budgeting framework and recommended budget practice statements.

The GFOA Committee on Governmental Budgeting and Management has continuously reviewed and been involved with the work of the Council. The GFOA Executive Board passed a resolution in support of its ongoing work in October 1997.

#### **Recommendation.**

The Government Finance Officers Association (GFOA) endorses the work of the NACSLB, including the NACSLB's definition, mission, and key characteristics of the budget process, stated as follows:

Definition of the Budget Process: The budget process consists of activities that encompass the development, implementation, and evaluation of a plan for the provision of services and capital assets.

Mission of the Budget Process: To help devision makers make informed chooces about the provision of services and capital assets and to promote stakeholder participation in the process.

Key characteristics of the Budget Process:

- Incorporates a long-term perspective;
- Establishes linkages to broad organizational goals;
- Focuses budget decisions on results and outcomes:
- Involves and promotes effective communication with stakeholders;
- Provides incentives to government management and employees.

Accordingly, the GFOA adopts the NACSLB framework for improved state and local government budgeting and recommended budget practice statements. The GFOA recommends that state, provincial and local govenments look to the recommended practices of the MACSLB as a model for evaluating and improving their own budget policies and procedures, with the goal of ultimately developing, adopting and implementing their budgets in accordance with these recommended practices. Given the evolving nature of good budgeting and management, these practices are not intended as mandatory prescriptions for governments. Rather, they are recommendations that provide a blueprint for governments to make improvements to their budget processes. Implementation of these practices is expected to be an incremental process that will take place over a number of years.

In addition to containing the same information as the bulletin, the packet will have the flexibility of adding new sections and articles to assist in the budgeting process. The website links users to other websites that contain current data used for budgeting purposes.

A notice advising finance directors of the new service which starts June 15 was sent mid-May. 
