## Guest Spotlight - Wayne Lowry President, Oregon Municipal Finance Officers Association

#### Oregon Local Government Issues

Wayne Lowry, Director of Finance for the City of Tigard, Oregon, shares with us some thoughts on what's happening "north of the border."

Since 1991, Oregon property taxes as a source of local government funding have been diminished by one initiative after another. Measure 5 passed in 1990, placing an immediate rate limit of \$10 for all non-school operating taxes on each property. Measure 5 also limited the use of General Obligation Bonds and the use of some forms of fees and charges.

In 1996, voters passed Measure 47. This measure would have rolled back property taxes paid on each property to 90% of the 1995/96 amount and then limited growth to 3% per year. As written, this measure would have reduced property tax revenues to some municipalities by up to 30%. The legislature referred Measure 50 to the voters in May 1997 to repeal Measure 47. This measure sought to retain the tax reduction features of Measure 47, but make the cuts in a more locigal way. The measure reduced property taxes by 17% on the average.

The Oregon property tax system was converted to a rate system by Measure 50. Values were reduced to 90% of 1995/96 levels and future growth was limited to 3% per year. Local tax authority was reduced by an average of 17% and then converted to a permanent rate. As a result of these changes, property tax revenues can only grow by 3% each year plus new construction.


With the continual attack on property taxes as a stable revenue source, local governments in Oregon have had to cut back on the costs of basic services and to lessen dependence on property taxes.

The Measure requires a majority voter turnout for all tax measures at any election except November of even numbered years. Many local governments have passed recent money measures only to have them fail due to the lack of majority voter turnout. A recent measure to eliminate the voter turnout requirement was narrowly defeated. November general elections in the future will be crowded with money measures. New strategies will need to be developed to educate voters on the merits of competing money measures without overwhelming and confusing them with information.

In the face of tax limitations and more stringent voting requirements, Oregon continues to grow and more demands continue to be made upon local governments for quality services. Creative solutions and the desire and commitment to work together will prepare Oregon municipalities for the challenges of the new millennium.

## Riverside "Raids" the Millennium Bug

The City of Riverside entered into a contractual arrangement with a private firm, Business Records Corporation (BRC), effective January 1997 to manage its information technology department. BRC began an immediate assessment of the City's hardware and software with regard to Year 2000 date issues and hardware obsolescence. An extensive evaluation of options led to the City's decision to purchase replacement hardware and software for all major systems. The project scope encompasses all major systems operating on the A16 mainframe as well as an assessment of infrastructure and desktop computer requirements.

Implementation of replacement systems will take the City from a mainframe environment to a open systems, client server operation. The City has approximately 1,300 desktop computers in a range of configurations. Many will require replacement to ensure compatibility with the new systems. A City-

wide replacement and obsolescence plan includes options to lease desktop computers as part of a technology refreshment strategy.

The City has established an aggressive time table to implement replacement systems. The project consists of three distinct phases. Phase I was to assess the magnitude of issues regarding Year 2000 compliancy and hardware obsolescence and to make a recommendation to address the entire scope of the problem. The decision to replace hardware and software led to Phase II, which included the selection of replacement software and configuration of new hardware. Riverside is currently in the final stages of Phase II and beginning Phase III, which includes conversion and implementation of replacement systems. Phase III will be additionally involved because the software selection process includes separate vendors for the utility billing system and the finance/human resources/payroll functions. Implementation of the various modules will be staggered to take advantage of diver-

gent software complexities and vendor and staffing time lines. Project time lines are still under development, but a target date of October 1, 1999

has been set for acceptance and signoff. Additional testing and modifications may continue beyond that date.

There have been several challenges to date during this project. The City of Riverside's infrastructure required extensive upgrade to accommodate the





replacement hardware. This involved replacement of routers and switches throughout City Hall and will include upgrade of the temperature control system in the main computer room and the wiring closets on each floor. Additionally, a widespread, long-range plan to replace or install wide area networks (WAN) throughout the City will be necessary to take advantage of the enhanced functionality of the replacement systems. Although this increases the one-time costs of the project, it does address ongoing technology access issues City-wide.

Project cost estimates of approximately \$9,600,000 were approved by Riverside's City Council in July 1997. Those costs do not include City staffing requirements for conversion and implementation or desktop computer replacement. Those costs will be addressed as the project progresses and additional needs assessments are completed. Critical path dates and budget targets have been met with the City using BRC as its systems integrator. The schedule is subject to revision based on resource commitments from all involved parties.

The "Year 2000" project at the City of Riverside will provide staff with major challenges throughout the coming months. Planning and organization are key elements to the success of managing such a complex project. Words of advice to the CFOs of the "Year 3000" project: Start early!
