President's Message

Greetings and Happy Spring!

It has been about a month since we enjoyed our wonderful Monterey conference, and, as usual at this time of year, things are heating up on several fronts.

One immediate issue we are now facing is the upcoming mandate from the GASB on infrastructure reporting. In March you all received a letter from the GFOA concerning the GASB's proposal that we record and depreciate infrastructure assets such as roads and bridges in our audited financial statements. The purpose of GFOA's letter was to urge all finance professionals to "directly communicate their views on infrastructure reporting to the GASB."

The CSMFO Board is treating this issue very seriously and we have taken several steps listed below to better inform our members and ensure that the concerns of cities are being addressed.

First, Bill Statler posted a message to our CSMFO e-mail group list giving more background on the infrastructure reporting issue and providing a sample letter (see attachment) for your convenience. A number of you have already responded, and we thank you for the prompt action.

Second, Harriet Commons and I had an extensive telephone conversation with David Bean, Director of Research for the GASB, in order to understand the issue as fully as possible and be clear on the process and the possibilities. David explained that the Reporting Model Task Force will be meeting on April 12th and will spend the majority of its time on the infrastructure issue. (Fortunately for us, CSMFO has three strong members of this Task Force: Barbara Hennessy from Long Beach, Rob Stout from Modesto, and Mike Moreland from Moreland & Associates.) Following the Task Force deliberations, the GASB will go

directly into meetings on the subject in mid-April. The GASB will issue a preballot draft in May, which means that changes can be made through the end of May. Our conversation with David was a candid one. He did tell us that, in his opinion, the infrastructure issue will not go away, but that there is an opportunity to make the implementation as pain free as possible for us as financial professionals.

Chapter Corner: Coachella Valley Chapter

The Coachella Valley Chapter meets every month except for the months of February and August. Chapter members are finance directors and staff from the desert cities, water districts and other governmental agencies in the Riverside County. Consultants from various fields who serve these local agencies are also frequent attendees. Networking among members at all levels of position is encouraged to promote valley-wide working relationship and sharing of ideas, expertise and resources.

Meetings are usually held on the third Friday of the month from 12:00 P.M. to 1:30 P.M. Some meetings are held on the third Monday in consideration of some cities that are off on Fridays. Having each city member host the meetings on different months not only gives the host an opportunity to showcase their city but also spreads the effort of the preparation for the meetings during the yea. Meetings have been made more interesting by the use of modern technology such as video conferencing; raffles and door prizes of the host city's official logo shirts, baseball caps, pins and bags; unique venues such as the Palm Springs Tram at the snow-covered top of the spectacular San Jacinto Mountain which included a free fifteen minute tram ride; timely topics not only in the field of governmental finance, reporting, taxes, laws and regulations but also outside this field such as the engineering of the rotating cable cars (that will be ready in September to replace the current Palm Springs tram ride), mentoring and career development - all given by dynamic speakers who are experts in their fields. Visitors are welcome to attend the monthly meetings and have the chance to visit the beautiful desert cities of the Coachella Valley, also known as the gold capital of the world.

Recently, a group of finance directors and staff have come together to offer assistance to a member city who is currently in dire financial crisis and staff shortages. The meetings presided by Greg Johnson of Indian Wells and attended by representatives from the cities of Palm Springs, Cathedral City, Rancho Mirage, Palm Desert, Indian Wells, Indio and Coachella resulted in the formation of a committee. The committee has concluded that rather than each city contributing staff time in resolving the immediate need of continued leadership and training of this city's skeleton finance crew for the next six months, a majority of the cities of this committee can offer financial contributions that will be used to hire a temporary finance director who can provide finance expertise, training, cash flow analysis and budget, audit and financial reports preparation. The committee has also invited consultants currently serving these cities to the meetings. These consultants namely, Rick Ashburn and Paul Whitelaw from Munifinancial/MBIA and Suzanne Harrell from Rod Gunn Associates, Inc. have already voluntarily provided valuable free assistance to this city in need in the areas of redevelopment agency, assessment districts, Prop 218 requirements and revenue enhancements. The committee continues to meet to oversee the efforts in assisting this city. This combined effort is truly a great example of a caring community at its best!

State Treasurer Introduces Local Investment Legislation, AB 1423 (Steinberg)

State Treasurer Phil Angeledies is sponsoring AB 1423 regarding further disclosure and reporting of local investments. The Treasurer's office has asked for the expertise and input of key municipal organizations to assist him in this endeavor. They wish to further fulfill their mandate in light of the legislation resulting from the Orange County Bankruptcy to educate and advise local officials and the public in the area of local investment practices and procedures.

Treasurer staff reiterated the willingness to work with local agencies to avoid mandates to the extent possible and to limit the burden of compliance with the measure. They are seeking data to fill the information void on the varying practices of local agencies particularly in the area of risk. The measure will address cities counties and special districts.

Participating in this high level meeting with key officials from the California Debt and Investment Advisory Commission (CDIAC), Local Agency Investment Fund (LAIF) and the Treasurers staff were Finance Director Bob Biery, Thousand Oaks, Director of Administrative Services Stan Lindsay, Santa Rosa and Treasurer Mike Reynolds, Riverside. Local officials, including county treasurers, expressed concerns with the proposed draft legislation and sought some helpful clarifying changes to the current measure.

This will be a work in progress which fiscal officers should pay close attention.

League Appoints New Director

The League of California Cities selected Christopher McKenzie from the League of Kansas Municipalities as the new executive director. His appointment was approved at the League board meeting on March 20. He will assume the position in June.

The top priority for McKenzie as he takes the helm will be continuing the League's efforts to strengthen local control and establish greater fiscal stability for California's cities. McKenzie brings more than 25 years of experience in local and state government, including County Administrator and County Counsel for Douglas County in Kansas and work in policy analysis and planning for Kansas' Division of State Planning and Research. McKenzie will fill the vacancy left by Don Benninghoven, who retired after 40 year of service with the League.

According to David, areas where we might have some impact are:
1) alternatives to the historical cost depreciation model

2) the phasing of implementation, along with other elements of the implementation plan.

Finally, the CSMFO Board held a meeting via bridge call on April 7th to take a formal position on the infrastructure issue to be conveyed by letter to the GASB. Included on the call were the three Reporting Model Task Force members mentioned above. After much discussion, the Board voted to prepare a letter that stated our strong opposition to the infrastructure reporting requirement but also set out possible alternatives for the GASB to consider. We all strongly felt that until an implementation plan is fully thought out, it would be ill advised for the GASB to adopt any specific reporting requirements. CSMFO will also be recommending that development of the implementation plan be done jointly with a group of government finance professionals, and we are requesting that our expert members be included in the implementation team.

In the meantime thanks again to Rob Stout and Bill Statler, who initiated our action on this issue, and to the Task Force members for representing us so well.
