Hopefully by the time this article is published, the State will have adopted its budget. We all need to monitor the State and Local Fiscal Reform Conference Committee and its actions as it allocates the \$200 million set aside for local government fiscal reform.

#### **GFOA CONFERENCE**

I attended the GFOA Conference in Chicago. Even though the theme of the conference was "e-Volving in a Cyber World," the GASB 34 sessions were the most popular ones. CSMFO GASB 34 Implementation Task Force will gleam any valuable information from the conference in its final product.

During the conference Mary Bradley, Bill Statler, Tim Hansen, and I had the opportunity to meet with GFOA Training Director, Cathy Floyd, to discuss future GASB 34 training in California. Some of the topics discussed are as follows:

1) CSMFO has a great interest in establishing satellite locations across the state to approximate our chapter organization. We are trying to get about 22 permanent sites within relatively easy driving distance of every member. We intend to use these locations to "receive" the three GFOA standard satellite broadcasts each year as well as any other broadcasts of topical interest. We understand that the three standard offerings are a GAAP update in November, a March session on Emerging Technologies, and a September session featuring Innovations in Public Budgeting.

- 2) GFOA is adding one day of GASB 34 training for the August Sacramento programs. GFOA is also offering GASB 34 training in January in Long Beach.

# Demand for Government Accounting Training Continues

Jim Ruane, with the Orange County Fire Authority in Southern California and Joan Streit, with the city of Albany in Northern California were recent hosts of the Introduction to Government Accounting course, aimed at providing front line staff with basic knowledge and concepts. There were approximately 88 participants between the two sessions, which consisted of finance, purchasing, budgeting and accounting administrative and clerical personnel. The sessions were instructed by local CPA firms of Moreland and Associates and Vavrinek, Trine and Day, respectively.

The training consisted of a combination of lecture, discussion and quizzes that kept the classes interesting. Look for future sessions of this class to be held later this summer and fall. Thanks again to our instructors, OCFA and city of Albany for hosting and coordinating these two successful classes.

# **Sacramento Update**

As this newsletter goes to print, the budget has been sent to the Governor for his signature and legislators are pushing to get their bills through policy committees by the July 7th deadline. Fireworks should be flying in Sacramento on July 5<sup>th</sup> as Senate and Assembly Local Government and Senate Revenue and Taxation Committees meet to review several bills of concern to local government.

#### **Budget Summary**

The Legislature sent the Governor a \$100.8 billion package to fund government for another year. The Governor will sign the bill prior to the July 1st deadline. He is expected to make significant revisions to the spending plan and implementing trailer bills. So with a warning that the Governor has an endless supply of "blue pencils," here are the budget items that relate to local government:

- Local fiscal reform \$200 million has been set aside for the State and Local Government Fiscal Reform Conference Committee to allocate. The committee has been meeting regularly and there is no indication when decisions will be reached.
- Road maintenance \$400 million split between cities and counties with a maintenance of effort clause. An estimate of \$7.14 per capita is anticipated for this purpose.
- COPS/Juvenile Justice \$242 million split between COPS and Local Juvenile Justice Treatment and Prevention Program. COPS funds will be distributed under current formula with a \$100,000 minimum per jurisdiction.
- California Law Enforcement \$75 million equipment procurement funds with a minimum of \$100,000 per recipient.
- Equipment Program Library Funding (CLEEP) \$15.3 million augmentation to a total of \$72 million in the Public Library Account.
- Flood Control Subventions \$68 million to fund the state's share of local flood control projects paid by local agencies.
- Brownfield Mitigation \$85 million for loans for toxic cleanup
- Park Bond Funding budget includes the allocation of \$338 million in per capita formula for local priority park projects.

#### Sacramento Update, continued

#### **E-Commerce and Internet Tax**

Both good and bad bills continue to work through the legislature related to the internet. Those that are still surviving include:

- AB 2412 restricts businesses operating in the state from establishing a "dot.com" affiliate to avoid collection of sales tax. Support.
- AB 1784 this bill extends the current moratorium on fees and taxes and was reduced from permanent to three years, still considered too long in this rapidly changing economy. Oppose.
- SB 1933 and SB 1949 related bills that would establish a commission to study tax policy in the new economy and direct the Governor to participate in multistate discussions of sales tax simplification measures. Support
- AB 83 this bill originally exempted screenwriters and artists with home-based businesses in Los Angeles from business license fees.
   The bill continues to change and move forward and now extends beyond artists, Los Angeles and home-based business. Oppose.

#### Cap on Property Tax Shift

Slowly but surely, SB 1637 continues to make its way through the Legislature. Senator Burton's bill would cap the property tax shift at the current level with any future growth distributed to local cities, counties and special districts. Next step for the bill is the Assembly floor prior to the end of August.
