Chapter Corner: Redwood Empire

The Redwood Empire Chapter covers Sonoma, Mendocino and Lake counties including 15 incorporated cities. Our Chapter meets monthly in Santa Rosa and we generally have at least 8 cities and our peers at Sonoma County attending regularly. The large geographic area of our chapter makes it difficult for our cities in Mendocino and Lake counties to attend every meeting. We send all meeting notices by email.

We had several interesting speakers this past year. In June, Brice Russell of Hinderliter, de Llamas & Associates discussed the future of sales tax and ecommerce. Jim Gallagher, Sonoma County Assessor, was our speaker in July and he discussed his annual report. In September, Rod Dole, Sonoma County Auditor-Controller, discussed current issues and opportunities in our property tax system and addressed several questions from the cities.

At the November meeting, Ben Stone of the Sonoma County Economic Development Board spoke about our region's economic outlook. All chapter members agreed that our cities have done well financially this past year and, despite signs of a mild recession approaching, remain optimistic about the future of our region.

Our annual holiday luncheon was in Healdsburg and over 60 people attended, including finance directors from 10 of our 15 member cities, their department staff, and our associates from the Sonoma County Auditor-Controller's Office. Before lunch, we broke into discussion groups to address such subjects as rising utility rates, GASB 34, current payroll issues, financing local government, and chapter activities in 2001. After lunch, our guest speaker was Mr. Chris Coursey, a well known columnist at the Santa Rosa Press Democrat.

In October and November, our chapter worked with GFOA to downlink two satellite teleconferences. Nine people attended a very interesting teleconference on performance budgeting, and 22 people attended the 2000 Governmental GAAP Update. The City of Santa Rosa hosted our downlink site in their Council Chambers and they provided lunch.

Our Chapter meetings are always upbeat, friendly and informative. We have an open exchange of information in our roundtable setting, and we have an interesting year ahead of us. One of our projects, to be launched in January 2001, is to support networking groups of our cities' payroll professionals and accounts receivable professionals. As finance directors, we encourage our staff to develop themselves and to network on a regular basis.

California's Economic Forecast

Brad Williams, Senior Economist with the Legislative Analyst's Office (LAO), discussed his predictions on California's economic outlook next year and related State budget implications at the Financial Management Seminar in San Diego. The discussion referenced key information included in several LAO reports available on the website www.lao.ca.gov. The reports and discussion provide a preview of some budget issues legislators may examine in the upcoming session.

California was slow to emerge from the recession and was hit hardest as the aerospace industry took a nosedive in the early 1990's. Computer services have been the leading factor in economic growth and employment gains. Employment in the computer industry is now more than twice that of aerospace and exceeds aerospace at its peak. Williams reported that indicators show continued economic expansion even with current reports of downturns in some sectors of the computer industry. Foreign trade has also fueled the California economy with exports increasing from \$70 billion in

1993 to an estimated \$130 billion in 2000.

This economic growth in California driven by this "New Economy" produced state revenue gains exceeding predictions by both the LAO and the Department of Finance. Revenues experienced almost 20% growth in the 1999-2000 fiscal year, better than the growth in the muchheralded 70's with personal income tax revenues lead revenue sources driven by stock options and capital gains. This growth should moderate in 2000-2001 and slow further the next year as the opportunity to exercise options expires and the stock market slows. Williams suggested that California should experience continued but slower growth in 2001.

The "New Economy" requires educated, skilled employees and expects an infrastructure that will support continued expansion. Housing, education and infrastructure needs will continue to capture attention throughout the budget process. At the same time, some demographic and economic trends

indicate shifts in State spending over the next few years. Spending requirements for Proposition 98 (K-14 education) is expected to slow over the next several years as the number of school age children starts to decline. The "baby boom echo" that accelerated the number of school age children over the last several years is starting to dissipate. On the other hand, the cost of health care could significantly increase Medi-Cal spending.

The LAO projects a \$10.3 Billion surplus in 2001-02, \$6.8 billion from 2000-01 and \$3.4 billion operating surplus in 2001-02. From this reserve, potential uses the LAO listed include \$2.5 billion (3%) budgetary reserve, \$4.4 billion in one-time commitments, and \$3.4 billion in new or expanded ongoing commitments. These economic and budget surplus projections coupled with anticipated demands on state spending should be considered as legislative priorities are developed. At the CSMFO board retreat, Intergovernmental Relations Committee and board members expressed concern over the lack of understanding on the cost of PERS retirement benefits for public safety for 3% @ 50. The committee decided to recruit knowledgeable professionals to write an article for Western City magazine clarifying the issues. Harriet Commons, senior consultant for the city of Fremont, and John Bartels, actuarial consultant with Aon Consulting, agreed to write the article that appears in the January edition of Western City magazine. Minimum Wage Increase to Affect Cities

Public agencies are no longer exempt from the State's minimum wage standards. The Industrial Welfare Commission (IWC) adopted a minimum wage increase that now applies to public employees. The result of this exemption removal is that all public agencies must comply with the minimum wage increase to \$6.25 beginning January 1, 2001, and a further increase to \$6.75 on January 1, 2002.

Many cities have inquired as to the IWC's authority to adopt minimum wage increases without legislative action. Provisions set forth in Section 1173 of the California Labor Code provide that "it is the continuing duty of the Industrial Welfare Commission . . . to ascertain the wages paid to all employees in this state, to ascertain the hours and conditions of labor and employment in the various occupations, trades and industries in which employees are employed in this state, and to investigate the health, safety, and welfare of those employees."
