### **Chapter Corner: North Counties**

The North Counties Chapter of CSMFO was revitalized during the past spring and summer months. Comprised of cities, counties and special districts in both Humboldt and Del Norte counties, this chapter met for a round table discussion and planning session in June 2001. During this kick-off meeting it was decided to meet every other month and various speaker topics were suggested. Attendance for the June and October meetings was over 20 finance professionals and in November we had 30 people listen to an excellent presentation on how to prepare for GASB 34.

Our second meeting was scheduled for September 11 with speaker Peter W. Miller, to fly in that morning from San Francisco. Needless to say, that day was spent by all of us in shock and doing anything but attending a CSFMO Chapter meeting! Fortunately Mr. Miller, Managing Director of Public Financial Management, Inc., was available during October to present his "Primer in Debt Finance." His presentation included various types of funding including Municipal Bonds, General Obligation Bonds, Assessment Bonds, Certificates of Participation, and Revenue Bonds. Mr. Miller's thorough presentation provided an excellent understanding of all the players involved in debt financing and what to expect from each participant.

Gary M. Caporicci, CPA, partner and co-founder of Caporicci, Cropper & Larson, LLP, presented his PowerPoint production on GASB 34 to our chapter in November 2001. Mr.

Caporicci is very well known as an educator in this area of financial statement transition. He provided a step-by-step overview of why municipal governments have to comply with GASB 34, how to get started, what are the new components of the Government-Wide Financial Statements, and deadlines for compliance. A lively discussion ensued on new reporting requirements for capital assets and infrastructure costs, with Mr. Caporicci emphasizing the need to develop an excellent working relationship with our Engineering/Public Works departments.

Our January 2002 chapter meeting will feature David W. Tyson, City Manager of Eureka, speaking on the budgeting

## Just in Time – New Revenue Collection Tool for Cities

Six years of effort are now paying off for the City of Los Angeles with the passage of AB 63 (Cedillo), Chapter 915, Statutes of 2001, creating opportunities for city business tax programs across the state. Los Angeles has recognized the value of the information the Franchise Tax Board (FTB) collects from business tax filers since 1995, when they first asked the FTB to compare state business tax records with their city business tax files. Because state law (Rev & Tax Code § 19551) prohibited the FTB from disclosing state tax information to city tax officials (though ironically allowing the information to be shared with other entities such as Mexico), the FTB sent city business tax notices to thousands of Los Angeles-based businesses they identified as not paying the city business taxes. Los Angeles collected millions in new business tax revenue in 1995 and began their pursuit of legislation authorizing the FTB to share their information with cities.

The Governor's signature on AB 63 creates the first opportunity for city tax officials to receive the name, address and type of business activity from the FTB on any tax filer reporting taxable income from a trade or business within that city's boundaries. AB 63 requires the FTB to recover its costs in providing this information (\$355K) from participating cities and the FTB has calculated an individual city's costs based on their percentage of the state's population (with a \$500 minimum). The FTB transmitted notices of the potential program to all cities in October 2001 and calculated costs based on 128 cities responding to the notice. FTB is currently sending agreements to 87 cities committed to the program for 2002.

The Board took two important policy positions at its December meeting regarding performance measurement:

- First, the CSMFO strongly supports the use of performance measures as part of the budget process based on "best management practices" set by professional groups such as the National Advisory Council on State and Local Budgeting, Government Finance Officers Association and the International City/County Management Association.
- However, the Board is equally strong in its opposition to the Governmental Accounting Standard Board's (GASB) initiatives regarding *Service Efforts and Accomplishments* (SEA) reporting as part of external financial statements.

### **By-Laws Changes**

At the September Board of Directors retreat, the Board established a goal for 2002 to develop an approach to incorporate Special Districts into CSMFO. Goal chair, Irwin Bornstein, presented a range of options to the Board at the December meeting, ranging from status quo to full active membership.

After some discussion, the Board recommended that special districts be afforded full active membership rights and instructed me as Administration Chair to draft the necessary by-laws changes to implement this recommendation. Members will vote on these by-laws changes at the annual conference in February.

If approved, the membership changes and dues adjustments will be effective with the 2003 renewals. Please review these changes so you are prepared to vote. The complete by-laws may be found at the back of your current CSMFO directory.

Proposed amendments to be voted upon in February 2002:

# ARTICLE II - MEMBERSHIP AND DUES shall be amended to read:

### Section A. Qualifications

- Membership shall be open to any person presently or formerly actively engaged in the field of municipal or special government district finance, in one of the following classifications, providing no direct conflict of interest exists.
  - **a. Active member.** This classification shall be open to

those municipal finance officers who are presently employed on a full time salaried basis as the chief fiscal officer of a city *or special* members *government district*, and have attained a professional level of performance, understanding and aptitude in the field of municipal finance...

- b. Government associate member. This classification shall be open to those persons presently or formerly engaged in municipal *or special government district* finance activities who do not qualify either as Active Members, Commercial Associateor membership in other classification.
- e. Special District Member
  This classification shall be open
  to persons presently employed
  on a full time salaried basis as
  the chief fiscal officer, assistant
  chief fiscal officer, or lead
  employee reporting to the chief
  fiscal officer of a special
  district.

### Section D. Rights and Privileges

Persons of all classifications shall be accorded full rights and privileges as provided hereinafter except that only those persons in the active member classification shall be accorded the right to vote and hold office with the exception of special district members when electing the special district liaison.

# ARTICLE III – DIRECTORS AND OFFICERS shall be amended to read:

**Section I. Special District Liaison** A special district liaison shall be elected by the members within the special district classification for representation at board meetings. The process for election is the same as for board members as defined in Article III. Section C. **Substitute Motion:** The liaison does not have voting rights and will phase out in February 2004 or prior if the position is vacated. The person filling the special district liaison position existing as of Jan 1, 2002 shall represent special district members on the Board without voting rights until the earlier of the position is vacated or until February 2004.

Some Background. GASB has been looking at SEA reporting for many years now. With GASB 34 now under its belt, many are concerned that GASB will now take this up with renewed passion and fervor. As detailed in a recent opposition letter by the GFOA to GASB (available on the GFOA's web site at <a href="https://www.gfoa.org">www.gfoa.org</a>), including this as a required component of external audited financial reports is an extraordinarily bad idea for a number of reasons. But perhaps the most compelling one is also the simplest: this is not what GASB exists to do.

Because of this, the CSMFO's opposition to SEA is fundamentally different than past disagreements with GASB on new standards like GASB Statements 31 (investments) and 34 (new reporting model). While we may not agree with all of the standards that GASB has set, we would be hard pressed to say that they weren't clearly in its realm of accounting and financial reporting. For example, many of us may not think that reporting and depreciating infrastructure has much practical value; however, I believe we would all agree that conceptually, capitalizing assets and allocating the cost over their useful lives is a legitimate "accounting and financial reporting" topic.

Stated differently, we may not always like the way that GASB referees the game, but they belong on the court. But SEA reporting is radically different: it addresses issues far removed from GASB's legitimate portfolio. And GASB needs to be dissuaded from even considering setting rules for a game they have no role in playing.

Lastly, maintaining GASB's credibility and independence is very important to our profession. For this very reason, the CSMFO strongly encouraged our members to implement an unpopular standard like GASB 34—even though we were equally passionate in our opposition to it before its adoption. In essence, the principle of an independent, authoritative standard setting body is more important than the specific accounting principles that it may adopt. But if GASB ventures into fundamental public policy (not accounting) arenas where they do not belong, they will undermine the important role that they play.

We have written GASB (and its "parent," the Financial Accounting Foundation) outlining our strong opposition to their taking any initiatives in performance measurement. And we will work closely with the GFOA and other professional associations in trying to "head-off GASB from this pass."


