# President's Message

# Greetings and Happy Spring To One And All!

It's almost April and the time of year when many of us (at least those of us classified as "weather wimps") are yearning to see more sunshine and warmer weather. It's hard to believe that it has been a month since we all met in San Diego and enjoyed getting together and sharing stories about our latest triumphs and challenges.

It's Budget Time Again! Most of us are already knee-deep in the budget process and looking forward to finishing this task. If your city, like mine, is approaching the second year of a twoyear budget cycle, the process is not so arduous – it's more of a review to see if the forecast we saw in our "crystal ball" last year is still accurate or if we need to make some adjustments to stay on track. Many economists predict that we're out of the recession (of course that depends on where you're located in the State of California) and that the times will continue to get better, albeit at a much slower rate than that realized after past recessions. In addition, we have the unresolved issue of the pending State budget deficit and how the gap will be closed. With the latest figures stating that the budget may be out of balance by a whopping \$17.5 billion, I for one don't feel real secure that the State will not suddenly turn again to cities, districts, and counties to help fill the gaping hole. We must all be ever vigilant and prepared to communicate quickly with our representatives in Sacramento as the time to enact the State budget draws nearer. Don't forget, if you don't voice your concerns, you can't expect Sacramento to heed your cry.

Oregon Conference. I just returned from attending my first out-of-state conference in Sun River, Oregon. Sun River is located in central Oregon near Mt. Bachelor. It is a lovely area which, upon my arrival, I discovered was still covered with snow and very cold. It snowed the first two days I was there, which was a real treat for this native San Diegan to watch the snowflakes fall and magically cover the ground and trees outside. On the day I left, it had all melted and although the area lost some of its magic, it was still a delightful place to attend a conference.

In addition, I was struck by how similar the concerns are for California and Oregon finance professionals. We're both contending with the implementation of GASB 34 (something over which we at least have a modicum of control) and development of local budgets with uncertain revenue sources as our State governments are facing significant deficits (an issue over which we believe we have very little control). Oregonians are facing many of the same fiscal issues as we are in California, especially in the area of shrinking dollars for providing essential services. So, don't feel all alone as you worry about how to finance services with the possibility of a state takeaway looming on the horizon, our neighbors are also facing a similar situation. This doesn't, of course, make our job any easier; it just sometimes helps to know that we're not alone.

# **Policy Committee Reports**

The League of California Cities' eight Policy Committees met in Ontario on March 21 and 22 to discuss key legislation requiring policy discussions and other policy issues in each area. Each committee has a representative from CSMFO and the League Fiscal Officer Department; these representatives have submitted the following summary reports from these meetings. The next policy committee meetings are scheduled for August 16, 2002, in Sacramento. Copies of agendas and meeting highlights are available on the League website at www.cacities.org.

#### **Administrative Services Committee**

Robert J. Franz, Glendale

The Committee reviewed the 2002 League priorities and the Committee's work program to determine where the Committee could contribute to the grassroots effort and the three top priorities that have been established by the League for the year 2002. The Committee anticipates working on the grassroots network as well as the efforts involving protecting City revenues.

The legislation being monitored by the Committee falls into two primary categories this year. First is election cleanup and second is legislation related to public records. Regarding election cleanup, the Committee is "watching" two bills. No position has been taken since they have not developed specific final language at this point. Public records requests and Brown Act issues are more prevalent in several bills being monitored by the Committee. Of particular note is SCA 7 (Senator Burton), which is a proposed constitutional amendment to the Public Records Act. As currently written, SCA 7 is opposed by the Committee. It would potentially require the disclosure of performance evaluation of public employees; disclosure of security plans for sensitive public structures, disclosure of City position on real property negotiations, and, lastly would result in increased litigation. This measure is being supported by both of the California Newspaper Publishers Association (CNPA) and the First Amendment Coalition. There have been court cases lost in recent years on Public Records Act requests and the proponents are using these losses to bolster their request for a new law. Attention has been drawn to records request issues by the State of California's energy contracts negotiated last year, former Insurance Commissioner Quackenbush's activities, and the Enron Corporation involvement in lobbying. This is a bill for all of us to watch closely.

#### **Community Services Policy Committee**

Jim Koser - Morro Bay, & Gary Nordquist - Fontana

The meeting began with a discussion of SB 1393 (Romero). Arsenic Treated Wood. Playground Equipment. The proposed legislation would ban the use of wood treated with arsenic for preservative purposes. The bill would also ban use of wood chips made from arsenic treated wood. The committee supported eliminating hazardous materials from play areas but had concerns with a January 1, 2003 effective date being too soon for cities to respond thereby creating liability issues. The committee also had concerns with how local governments would find funding. In the end, the committee voted unanimously to support SB 1393 with the proviso that League lobbyists suggest language (a) to prioritize funding grants from Prop 40 funds to pay for the expenses, and (b) to provide for assessment and corrective action over a 3-year period.

# **Chapter Corner: San Gabriel Valley**

We recently had the good fortune of hosting the erudite and ever-in-demand Tim Schaefer of Fieldman, Rolapp & Associates as a luncheon speaker. With Tim's permission, we summarize his presentation below.

#### Six Steps to An EffectiveCapital Plan

#### (1) Establishing Goals

Understanding the role of your planning horizon. It makes little sense to try to plan for a ten- or twenty-year horizon if innovation, technology, demographics or legislative threats to the plan occur often.

Integrating the use (or lack thereof) of reserves in the process. The key is to make the reserve accumulation or depletion work in harmony with the capital plan, the operating budget and the risk management philosophy of the agency.

Understanding the iterative nature of implementing the CIP. Great benefit can be derived from the repetitive process of reviewing and updating the CIP annually. By doing so, the capital plan is tempered by current information on the financial and political priorities of the agency.

#### (2) Assessing Needs

The needs assessment is the foundation for virtually all of the decisions that will arise in the capital planning process. Needs assessment should rely on a comprehensive inventory of capital assets already owned, an estimate of their remaining useful lives, and a solid understanding of the requirements for the future.

Useful tools in the operation of the needs assessment may include community focus groups or commissions, local and regional planning agency studies, staff input, and reviews by engineering, accounting and legal experts.

# (3) The Strategic Decision – Buy or Borrow?

"Pay-as-you-go" or "pay-as-yourequire" strategies rest on the inherent fiscal conservatism of an approach that says "a dollar not borrowed is a dollar on which interest need not be paid."

"Pay-as-you-use" proponents usually argue that the agency's stakeholders should "pay" for the assets required to deliver the goods or services of the agency over a time horizon that closely mirrors the useful life of those assets. Most agencies use a blended approach. In the end, the decision is often dictated as much by affordability as it is by philosophy. Few public bodies can afford (in either a political

or economic sense) to pay cash for all capital assets. Similarly, financing of smaller capital goods, or those with short or uncertain useful lives, is also inefficient.

#### (4) Identify Methods Available for **Financing**

Give thought to the collateral aspects of decisions. For example, if an asset is to be procured for cash, and the cash has been set aside in a reserve for that purpose, a decision still must be made regarding restoration of that reserve.

Choosing to issue debt is a tactical decision. Many things must be established in a financing plan: the form of debt needs to be selected, fixed or variable rate; term of the debt; repayment terms; methods of sale, etc.

#### (5) Designing the Loan – The Tactical Plan

Basic choices include borrowing from banks or private lenders or public offerings; lease financing; or "pooled" financings with similarly situated agencies designed to increase efficiencies of scale.

This element of the capital plan should also carefully consider other needs within the strategic plan when pledging assets or revenues to lenders. A generous package to a lender on today's asset may make tomorrow's asset financing problematic or impossible.

The key is to ensure that each tactical financing plan within the CIP works harmoniously with other elements of the plan and is flexible enough to allow for the inherently changing nature of the capital plan.

#### (6) Organizing the Approach

The successful capital planning process looks a great deal like the successful budgeting process: it clearly articulates goals and objectives of the organization to all stakeholders; it relies on accurate and unbiased assessment of needs; it provides for a "vetting" of the desired assets to distinguish between "wants" and "needs;" it is written down and shared with the agency's stakeholders; it is revisited often and provisions for amending it are straightforward; it incorporates period analysis of results and achievements for oversight.

#### **Summary**

The Capital Improvement Program is the strategic plan for the acquisition and implementation of capital assets. The CIP should contemplate how those goods will be paid for - cash or debt - and should establish order and timing. The financing plan is the tactical plan that focuses on individual acquisitions and how to pay for them.

#### **Double-Click Problems**

If you're finding that you are having to repeatedly double-click to get Windows to perform an action, you may have your double-click timing too high.

To change this setting, click on Start. Move the cursor up to Settings, which will bring up a pop up screen. Move to Control Panel and single-click. Now locate the mouse icon and double-click. This will open up Mouse Properties screen. Select the Buttons tab. Move the slider located in the bottom half by

selecting and dragging toward the slower end. You can test the speed by double-clicking the Jack-In-The-Box to get the right speed. If it's still too fast or too slow, try again. Click Apply when finished, then OK to exit. Close the screen by clicking on X in top right hand corner. You should be back to the desktop.

If you're interested, there are tabs at the top of the page for Pointers and Motion. By selecting these tabs you can make changes to the way your cursor appears on the screen.



#### **Community Services Policy Committee** (cont'd)

The committee heard from Kathy Limbo, Executive Director, South Bay Community Services, a community-based organization that has develop symbiotic relationships with schools, cities and other non-profits in its area. This was an interesting example of using "partnering" to avoid (1) duplicative services, (2) competition among non-profits for the same dollars and (3) diversifying funding to shield it from funding fluctuations among its sponsor organizations. The committee will continue to monitor skatepark liability, seeking to eliminate the existing sunset provision.

#### **Employee Relations Policy Committee**

Robert F. Locke, Mountain View

The Employee Relations policy committee discussed the League's strategic planning process, committee responsibilities for implementing the strategy, legislation and the role of the Grassroots Network regional coordinators. The highlights of the discussions were as follows.

- Strategic Planning: Discussion regarding Leagues strategic goals for FY 2001-02 covered in the March, 2002 Western City magazine. Amy Brown, legislative representative, indicated the League was forming closer ties with unions as part of a strategy to strengthen the League's influence and defend our revenue sources by presenting a more unified position in Sacramento. It was recommended that cities encourage their union representatives, especially police and fire as well as SEIU and others as well, to support the League's efforts to protect city revenues as it is in the mutual interest of management and labor that by preserving revenues we protect jobs.
- Regional grassroots representatives City staff are encouraged to contact them, develop relationships and understand their role. Possibly have them speak at council meetings.
- Legislation Discussion: The most important Employee Relations bills discussed include the following.
   AB 2908 (Goldberg) Gives the Public Employment Relations Board jurisdiction to determine the "reasonableness" of local labor rules, not just administrative jurisdiction over an unfair labor charge based on the local rules. Would usurp local control to determine its labor practices. Oppose.

AB 2889 (Shelley) – Essentially, would grant agency shop upon request without election. **Oppose**.

AB 1974 (Pescetti) – Would permit PERS to create risk pools for cities with less than 100 employees, currently a spot bill. **Watch**.

#### **Environmental Quality Policy Committee**

At its March 21, 2002 meeting, the EQC reviewed proposed legislation regarding **Solid Waste** and recommended opposition to SB 1587, Solid Waste Facilities, (Romero), and SB 1526, Zero Waste Conversion Technology. Out of State Disposal (Romero). The Committee recommended support for a negotiated 25% credit as opposed to the proposed 10% credit for AB 939 waste as part of AB 1952, Conversion Technology, AB 939 Credit (Bogh). The Committee opposed unless amended SB 1374, Construction & Demolition Waste Local Ordinances (Kuehl) and supported SB 1542, Solid Waste Facilities Environmental Justice (Escutia).

Bills related to **Hazardous Materials**, SB 1393, and SB 1523 received support or support if amended recommendations. A number of bills addressing **Water** issues, primarily those related to water quality issues, also received support including AB 2185, LA Regional Water Quality Control Board, SB 1994, California Clean Communities and Petroleum Pollution Cleanup Act of 2002, SB 1342 Stormwater Permits, AB 2351 Water Quality Mandatory Minimum Penalties. A very controversial bill, AB 1058 Vehicle Emissions Carbon Dioxide Greenhouse Gases, was discussed but no position taken. This bill is related to the Kyoto Accords, which the U.S. has not signed. A presentation on Storm Drain issues related to NPDES permits concluded the meeting.

#### Housing, Community & Economic Development Committee

Leslie Suelter, Encinitas

The Committee has three legislative priorities for 2002. The Committee is opposing SB910/SB262 (Dunn) that proposes shifting land use authority over housing elements to the state, and seizing local gas taxes or VLF revenues as a method of enforcement. The Committee is supporting efforts by Assembly member Longville on a comprehensive housing element reform with AB2863. This bill addresses several issues, among them developing fiscal tools and incentives to assist local governments in their efforts to encourage housing and finance the infrastructure to support housing, and establishing ongoing state commitment to funding affordable housing. Along these lines, the Committee is also supporting AB1227 (Burton) and AB1927 (Kehoe) that seek to provide additional tools to local governments to address housing and infrastructure needs.

The committee reviewed and agreed to support if amended SB1509 (Dunn), which would shift property tax back to the local entity for property tax losses for any affordable housing units operated by non-profit agencies approved after 1/1/2003. This bill requires, as a condition of receiving reimbursement, that the local jurisdiction's housing element be determined by the state Department of Housing and Community Development to be in substantial compliance with the existing housing element law. The Committee supported the concept of the property tax reimbursement, consistent with one of its legislative priorities, but directed League staff to negotiate with the author on the language related to the compliance precondition.

Craig Robinson, City of Roseville Assistant City Manager, discussed the pitfalls of AB680 (Steinberg), and challenged the purported benefits, such as smart growth. His presentation pointed out that the legislation does nothing to address growth issues...but gives the state more control over local issues. It redistributes local revenues on a three-pronged formula—1/3: situs; 1/3 population; 1/3 based on meeting undefined mandates. The imposed mandates are related open space, affordable housing, and homeless and domestic violence shelters without addressing the commonly accepted principles of smart growth, such as development paying its way, balanced land use, and investment in infrastructure. This legislation is targeted to cities and counties in the Sacramento region, including El Dorado, Placer, Sacramento, Sutter, Yolo, and Yuba Counties. However, the legislation exempts from the mandates 17 of the 29 agencies in the region. So, although intended as a regional solution, it is not. As an alternative to the revenue redistribution in the bill, Roseville drafted a regional fees proposal that has been presented to the bill's author.

#### **Public Safety Committee**

Mary Jo Walker, Santa Clara

Several informative presentations were made to the Committee, including:

- Racially-Biased Policing Don Casimere, Director of Police Accountability, Sacramento Police Department, summarized the process and extensive community involvement in his city's recent study entitled the "Vehicle Stop Data Collection Report" which was conducted to determine if racial profiling was evident in stopping traffic violators. The final report, prepared by an independent analyst, concluded that racially-biased profiling was not evident.
- ◆ Homeland Security Dan Furtado, Vice-Mayor of Campbell, presented a summary from the National League of Cities Homeland Security Taskforce. One of the key demands the taskforce will make to the federal government is to provide direct funding to local governments (the first responders). It should be noted that President Bush has proposed \$3.5 billion in the FY 03 budget for a first responder initiative. There is some discussion that this money could be available through a "block grant" type of disbursement.
- Fire Department Finance A briefing paper has been prepared by the Fire Chiefs Department that summarizes the legislative and administrative programs that will enhance funding for Fire Departments. A copy of this report may be obtained through the League.

#### Public Safety Committee (cont'd)

◆ AB1917, Mathews (Off-duty Peace Officers Carrying Firearms) - Todd Rogers, Council Member from Lakewood, spoke in support of AB 1917. SUPPORT with amendments for additional training requirement for use of firearms in airplanes and remedies if a business prohibits access to an off-duty officer with a concealed weapon.

- ◆ AB 2018, Nakano (Integrated Public Safety Communications System and Advisory Board) SUPPORT with amendments to add Santa Clara and to include a city representative on the Board.
- SB 1959, Polanco (City Audit of Bingo Games Grossing Over \$1,000,000) OPPOSE (Puts undue administrative burden and expense on City Finance Departments, independent audit costs should be born by charitable organization).
- SB 1549, Battin (Indian Gaming Special Distribution Fund) SUPPORT with amendment to explicitly prioritize public safety.
- ▶ SB 1528, Vincent (Reduction of Impound days for Shopping Carts) SUPPORT
- ◆ AB 2133, Goldberg (Law Enforcement Data Collection) OPPOSE (Puts undue administrative and financial burden on Police Departments)
- ◆ AB 2211, Horton (Community Impact Statement) SUPPORT
- SB 1807, Chesbro (Firearms Confiscation in Domestic Violence Cases) SUPPORT
- AB 2499, Frommer (Criminal Procedure Domestic Violence and Sexual Abuse Records) SUPPORT

#### **Revenue & Taxation Policy Committee**

Bob Biery, Westlake Village, & Mary Bradley, Sunnyvale

- Presentation by Assembly Member Lynn Daucher (former member of LCC R&T Comm.) on her bill AB1939 relating to local government finance. She stated that her bill "creates the Local Agency Empowerment Act of 2002, a voluntary program that:
  - 1. Empowers local governments;
  - 2. Discourages fiscalization of land use;
  - 3. Promotes cooperation among local governments;
  - 4. Provides dollars for affordable housing;
  - 5. Restores fairness and rationality to California's 30-year-old property tax allocation formula."

After the presentation and the discussion that followed, the Committee recommended a support position on the bill by majority vote.

- Presentation by Dan Flynn from Assembly Member Wiggin's staff on AB2878 also relating to local government finance. Committee recommended an oppose position.
- Presentation by John Russo, First VP LCC, and Chris McKenzie, Executive Director LCC, on proposed ballot measure and SB680. The LCC Board of Directors has determined that the conditions were not favorable to proceed with a ballot measure at this time, but may consider such an action for March 2004. The League has had some discussion with the author of AB680 (Steinberg) about the possibility of revising the bill to include provisions for local government constitutional revenue protection. The Committee took action to recommend continued opposition to the original form of AB680 and authorized staff to continue to work with the author for constitutional revenue protection.
- Presentation by Charles Summerell, Institute for Local Self Government, relating to 2001 report, The Fiscal Condition of California Cities. All cities should have received copy of the report.
- State Board of Equalization Task Force (Dave McPherson/Glenn Everoad) provided an update on regulations that the SBE is considering at this time. Often these regulations have more fiscal impact on cities than bills that the legislature enacts.




