## President's Message

As I write this, the November election is just a week away. I know we are all hopeful that a majority vote on Proposition 1A will give us the protection we need from future state take-aways. There are 15 statewide ballot measures on the November ballot. The CSMFO Board of Directors has taken a position to support Proposition 1A, but has not taken a position on any others. The League of California Cities has taken a position on five ballot measures, as follows:

Prop. 1A	Protect local revenues	Support
Prop. 59	Access to government information	Support
Prop. 65	Local government funds	Oppose
Prop. 68	Tribal gaming compact renegotiation	Oppose
Prop. 70	Exclusive gaming rights	Oppose

You can obtain non-partisan information about all of the ballot measures by logging into a website sponsored by UC, Berkeley. The website address is: <a href="http://www.igs.berkeley.edu/library/htProps1A&65LocalGovtRevenues.html">http://www.igs.berkeley.edu/library/htProps1A&65LocalGovtRevenues.html</a> this website gives you all of the arguments in favor of or against each measure and also tells you which groups or individuals are supporting or opposing them.

Assuming Proposition 1A passes, one thing we can still count on is that there will be other challenges - legislative and regulatory - that will need our attention and expertise. I encourage you to become more familiar with federal and state legislation - and to volunteer your expertise to CSMFO. CSMFO is relatively new in its role of advocacy for local government finance issues. Mary Bradley and Gary Nordquist are heading up a project which will identify those CSMFO members who have an expertise in certain areas and who would be ideal representatives of CSMFO in Sacramento. Who better to be a spokesperson for local government finance issues than a local government finance professional? You can contact Mary Bradley at (408) 981-4021 (mbradley@ci.sunnyvale.ca.us ) and Gary Nordquist at (909)350-7690 (gnordquist@fontana.org) for more information and to offer your services. Some of the areas to be thinking about include the Streamlined Sales Tax Project related to internet and remote sales, Voice-over Internet Protocol and Internet Tax Freedom efforts at state and federal levels which could hurt Utility Users Tax and continuing discussions on sales tax matters at the State Board of Equalization. Finally we need to examine what the real impacts of the triple flip and VLF property tax swap on revenues and cash flow, so we can encourage whatever legislative clean up measures are necessary to make them work right.

On December 1 – 3, at the League of California Cities Financial Management Seminar (Monterey), many of these issues will be covered. There will be sessions on the Economy, State and Local Fiscal Reform, Federal and Regulatory Proposals on the Horizon, GASB, PERS, just to name a few. You can view all of the sessions being offered on the League's Website at www.cacities.or/resource\_files/22809.04%20Announcement. Continuing discussion about many of these issues will occur at the CSMFO conference February 22-25 (Burlingame). These seminars are packed with valuable information. One last thought, Please don't forget to vote!



## **Bridging Our Financial Future**

The 2005 Annual Conference is in the final planning stage and is shaping up to be a major event. The conference dates are Wednesday, February 23 through Friday, February 25, 2004. This is a change from prior year conferences, which started on Sunday and ran through Tuesday.

Keynote speakers have been confirmed. On Wednesday, February 23, the featured speaker is Claire Shipman, Semor White House Correspondent for ABC News. She will speak on societal and economic challenges facing the nation. The Honorable Willie Brown will address the conference on Thursday, February 24 and State Controller Steve Westly will give the closing address on Friday, February 25.

The Hyatt Regency at San Francisco Airport (SFO) will serve as the official conference hotel. All business meetings, sessions and luncheons will be held there. It is located in the City of Burlingame less than 10 minutes from SFO. Complimentary airport shuttle service is provided from San Francisco International.

The conference rate is \$145 single or double occupancy. Call the hotel direct at 650/347-1234 or at 800/233-1234 to make reservations. The cut-off date for these special rates is January 22, 2005.

Three major airports serve the Bay Area. They are San Francisco International (SFO), Oakland International (OAK) and Norman Y. Mineta/San Jose International (SJC). Southwest Airlines has service only to Oakland and San Jose.

Conference registration packets are being printed and will be mailed to CSMFO members in December, these will also be posted to the website as soon as they are available. Look for them soon.
