

League Board Report

The League Board met in Monterey July 29-30, and discussed a number of issues of immediate importance.

Pat Dando, Governor Schwarzenegger's Director of Local Government Affairs, appeared at the meeting to ask the League to support and actively promote Proposition 76, the Governor's Live Within Our Means budget proposal, on the November special election ballot. The Board referred the matter to a special meeting of the League's Revenue and Taxation Policy Committee, and will then consider the committee's recommendation at a subsequent special meeting of the Board. The Board reviewed all eight measures that have qualified for the special election and determined that only Proposition 76 has a clear and fundamental municipal impact. Accordingly, the League will consider taking a position on only that measure.

In other action, the Board received a report from its Housing/General Plan Task Force, and held small group discussions on some of the issues being discussed by the task force. The Board also was presented an update on telecommunications and the impact of the continuing changes in technology. VoIP – voice over internet protocol – is perhaps the next biggest technology change we will see. The issue of a new regulatory scheme for the communications industry –video, data and voice – will be an extremely important issue facing local government over the next few years. Both the State Legislature and Congress will consider legislation in this area in the coming months. The League has drafted a set of 16 Communications Principles to guide the debate. Local communities are encouraged to get up to speed in this area and become knowledgeable of the issues, so that local interests can be protected.

On its legislative agenda, the Board approved the legislative positions recommended at the League policy committee level for all bills except one: the Board voted to oppose AB 566 (Bermudez), relating to reporting of fire staffing levels and response times; the Administrative Services Committee had recommended a neutral position. In addition, the Board also voted to oppose SCA 15 and ACA 22, which would severely restrict the use of eminent domain in redevelopment project areas. The Board felt this would undermine a seldom used, but nevertheless a key redevelopment tool.

In addition, they have been examining some cost sharing opportunities for the Annual Conference.

Agnes Walker (Costa Mesa) is chair of the **Budgeting and Management Reporting Committee**. Her committee consists of Cindy Guziak (Orange County Fire), Gina Schuchard (Santa Clarita), Pamela Arends-King (Seal Beach), and Anita Lawrence (Camarillo) as senior advisor. The budget committee is in full swing having received 21 budgets by August 25, with many more to come. The reviewer form has been updated on the web site to make the process even better.

The **Career Development Committee** consists of Viki Copeland (Hermosa Beach) – chair, Ronnie Campbell (Lakewood), Greg Baird (Modesto), Christy Pinuelas (Camarillo), and Mary Bradley (Sunnyvale) – senior advisor. In addition, the committee has worked extremely hard on three training goals for this year: 1) Training to address best methods of presenting and communicating financ8ial information to the public; 2) A new delivery method for Beginning Accounting training; 3) Development of individual skill sets, CFO reference manual, and resources list guide. All goals are in progress with some almost at the implementation stage.

The **Debt, Retirement and Treasury Committee** Pauline Marx (San Francisco) – chair, Josh Betta (South Pasadena) and Bill Statler (San Luis Obispo) – senior advisor. The committee has reviewed the PERS initiative and are preparing a synopsis of their evaluation for the next MiniNews. They often works in conjunction with the **Intergovernmental Relations Committee**: Tracey Hause (Arcadia) – chair, Rob Sousa (Benicia), Jesus Nava (Burlingame), and Irwin Bornstein (Mission Viejo) – senior advisor, successfully hosted the Legislative Update in May and through the total effort of Anita Lawrence also hosted a finance officer's submit that is now going to be a yearly meeting of all the groups that represent government agencies in California. If this is not enough, they are charged with two goals related to organizing and mobilizing a team of technical advisors to provide opinions and testimony on state and federal legislative and regulatory issues; and are also attempting to mobilize a budget team to discuss local issues with the Department of Finance and legislative budget staff.

Bill Thomas (Rancho Cordova) – chair, Sandra Schmidt Las (Virgenes MWD), Gavin Curran (Laguna Beach), Jesse Takahashi (Campbell), and Senior Advisor, Genie Roberts (Temecula) are the members of the **Professional and Technical Standards Committee**. At the Board meeting in May, the committee presented a proposal to the Board to extend the filing dates of the CAFR to coincide with the GFOA program. The new dates are in effect for this year. So, some of you can now breathe a sigh of relief!

The **Technology Committee** is chaired by John Adams (West Hollywood) with Tamara Hass and Barbara Boswell, and Julia James – senior advisor rounding out the committee. This committee is loaded with ideas. They are very close to offering the membership directory on line, which can also be updated on line. In the coming months they are also going to be reviewing survey software and exploring membership benefits on the web page.

Before year end, college students interested in pursuing a career in our field will be evaluated by the members of the **Scholarship Committee**: Stephen Conway and Candis Hong.

As you can see the year is extremely busy and many are hard at work to make our organization not only what it is today; but also looking forward to the future. The survey that was submitted to you in mid-August will assist the Board in assuring that we are meeting your needs. CAFR Program Update

As previously reported, the CAFR award program will change with the fiscal year ending June 30, 2005. CAFRs are due six months after the close of the fiscal year. Thus, for the majority of the CAFRs, they will be due by December 31st. For the two cities that report on a September 30th year end, they will be due by March 31st. As was the case last year, all CAFRs will need to be submitted to the following address:

The review period for the CAFRs has been extended and the award notification will be within 6 months of the receipt. This is due to the extreme inability of the committee to find reviewers that provide this most valuable assistance to the program. The resulting impact will be that the awards will no longer be recognized at the annual conference. The CSMFO will officially recognize award winners through the MiniNews as awards are given. Unlike the GFOA, CSMFO will acknowledge all winners not just new recipients.

The application for the FY 2005 award is being finalized at this time. Due to changes in GASB, the application will be slightly modified. Special Financing Districts

What is a Special Financing District?

The term Special Financing District ("SFD"), while not part of the legal lexicon or State statutes, means all Special Assessments and Special Taxes that are levied by local public agencies on parcels of land, defined as follows:

- Special Assessment This is a charge that is levied on parcels of land or businesses, based on the *special* benefit received from a service or capital improvement. The benefit criteria and formula is typically called a Method of Assessment. This levy is often called a "Special Benefit Assessment" or just "Benefit Assessment."
- Special Tax This is a charge that is calculated via some type of special tax formula (or Rate and Method of Apportionment in the case of a Community Facilities District) and levied annually on property for a defined period of years.

An SFD is almost always a dependent entity, tied to a city, county, school or special district. An SFD is not to be confused with a Special District, such as a Water District.

What does the legal landscape for SFD's look like?

To attempt to understand the nuances behind the discussion of Special Assessments and Special Taxes, one must start with the two major initiatives known as Proposition 13 and Proposition 218.

Proposition 13 mandated a roll back to a 1% property tax rate at the commensurate assessed value of the property, and limited other related revenue sources. This meant that local governments were severely limited to raising revenues for various efforts by simply raising property taxes.

Proposition 218, the "Right to Vote on Taxes Act," was approved by voters in 1996. This created a complicated categorization between assessments, taxes, fees and charges, with a commensurately complicated approval process for each category, many with conditions that affect the process itself. The implementation and understanding of Proposition 218 has been long and arduous, and continues today. Special Assessments and Special Taxes are two distinct groupings that require different methods of initiation and approval, as well as ongoing administration. Many people, even experts in the field, confuse and interchange the terminology of "Special Assessment" and "Special Tax," but there is a difference.

There are many types of Special Assessment and Special Tax State statutes that local government may use, as well as Charter City law. Currently, these are the most popular:

- Mello-Roos Community Facilities Act of 1982
- Landscape & Lighting Act of 1972
- Benefit Assessment Act of 1982
- 1913/1915 Assessment District Acts
- Property and Business Improvement District Law of 1994

The first of this list is a Special Tax while the latter four are Special Assessments.

Why Form an SFD?

SFD's can provide funding for a myriad of services and capital for many types of infrastructure. Though they have been around for many years, the trends over the last few decades have bolstered their use and popularity.

In terms of newly developing areas, the trend has been toward a national consensus that "development must pay its own way." This trend has been fostered by a number of factors. Chief among these factors is the downturn in Federal and State spending. Such spending peaked in the 1960's and again in the 1980's, but has declined significantly since then. Exacerbating this has been the numerous efforts to limit taxes by the voters. SFD's can provide the types of funding for new development needs.

In more developed areas, the requests for increased and enhanced services continue. Added to these demands are the additional requirements that local governments must comply with, such as the National Pollutant Discharge Elimination System or "NPDES." Of course, all of these demands come at a time of shrinking revenue sources and voterbacked tax limitations and reforms. That makes a strong case for the creative, but well crafted, use of SFD's.

Whether the need is in a newly developing area or a well settled one, there seems to be a trend for focused local sources of funding with direct accountability. The factors to be considered for any SFD include:

- Fairness and Equity
- Market Sensitivity
- Potential for Approval
- Timing and Predictability of Revenues and Expenses (and any need for debt)


